Durgin Vice Chairman



To the Editor, Milton Record-Transcript; On August 6, 1938 and December 1, 1969, two Home

December 1, 1969, two Home Farm barns in Milton burned to the ground. In 1938, the great barn was struck by lightning when it contained 88 head of pedigree cows and 100 tons of hay.

It was just at milking time so the head herdsman shouted to the men to release the cows from their head-stalls. This herdsman, to amuse himself, had

to amuse himself, had trained the cows to follow him when he sang to them in

his beautiful tenor voice. With the roof of the barn in with the roof of the barn in flames he sang to his cattle and they followed him without panic or confusion out to the pastures. Eightyeight percent of the best pedigree stock in this country was saved by a song.

A new model great barn was built on the foundation. Years pass. In 1969 cows were no longer in the barn. Many fine houses have been built over the land where crops of corn fluurished. The crops of corn flourished. The barn became a display centre with wall to wall carpeting and showing household goods and

chattels.

My family and I live across the street and at a quarter of eleven at night we took front row seats for the greatest display of fireworks Milton has ever seen. This spectacle cost, so I understand, \$500,000. So

ADVISORY BOARD SELECTS DOVER ST.

A two year battle against rapid transit extension through Milton came to a successful climax when the Advisory Council of the Metropolitan Bay Transportation Authority approved the Dover street yards as site of the MBTA's repair and storage yards.

The approval, which was unanimous, puts to rest the fears that the MBTA's storage yards would be transferred to Mattapan, which would mean rapid transit extension through the town from Ashmont to Mattanan

Mattapan.

It was commonly known that if the MBTA couldn't get approval of the Dover street yards, the body would

seek the Mattapan site.

A week-long series of meetings between the MBTA and Boston Mayor Kevin White paved the way

for the approval of the Dover yards, for which the MBTA paid \$7 million.
Originally Mayor White was opposed to the move because Boston stood to lose some \$150,000 approvide in some \$150,000 annually in taxes but through the meetings he worked out an agreement with the MBTA which was acceptable to

both parties.

The plan's five major points were:

onits were:

1) Boston and the MBTA
will draw up a plan for
development of the land
before April 1, 1970.

2) Boston has a five year

exclusive option to purchase any land at the site not needed for transportation. 3) The city has a ten year option to purchase air rights

option to purchase air rights over the site.

4) The MBTA surrenders to Boston an option the authority has on 14 additional acres of Penn Central RR property adjacent to the site.

5) Boston gains first option to buy any MBTA property anywhere in the city not needed for transportation purposes and the sportation purposes and the MBTA cannot sell any of its Boston property without the

city's permission. Various Milton town officials commented on the decision. Their comments

approved."




